MINUTES OCTOBER 21, 2019 MEETING

Roll Call/Delegate List - Present: Kim Abramson, Dorothy Beasley, Adrienne Bishop, Jim Hanley, Jim Harvey, Betty Munson, Chris Nichols, Rick Sayers, Roxanna Shamay. Absent: Floy Creveling

Agenda - Approved, although rearranged because the emergency community meeting in Joshua Tree meant the HVCC meeting must be shortened, and some speakers unable to attend

Minutes of the September meeting - Approved

Treasurer's Report: Floy Creveling, read by Jim Harvey, approved

1. Guest Comments on items not on the agenda - Question, addressed by Supervisor Rowe

Items 2-5, 7-8 removed to shorten meeting.

6. SB County 3rd District Supervisor Dawn Rowe

-Farmers Market original permit has not been modified either for increased number of vendors or hours of operation. Environmental Health Services responding to a complaint from other business; market must comply or relocate. -The community meeting in Joshua Tree for which Rowe had to leave early concerned State Department of Hospitals informing San Bernardino District Attorney that Ventura County Superior Court recommends releasing a re-offending violent sexual predator into rural Joshua Tree, after Sacramento County refused him. Sheriff John McMahon, Supervisor Rowe, and the

District Attorney's office called the meeting to alert citizens. Cpt Trevis Newport, ordinarily in attendance at HVCC, was to inform them of the court proceedings and options available. Voicing opposition is likely.

-Rowe reviewed the expansion of County Fire Protection Zone 5 (FP-5) to meet budget shortfall by adding \$157 to every parcel's tax bill without owner input, except by a protest process designed to fail. The Board of Supervisors has repealed the FP-5 expansion, limiting the tax levy to two years, while County Fire works on budget cuts, including addressing new equipment purchases, and sending three people on a fire truck to answer a medical emergency. Also a new Fire Chief may bring new ideas. Voters would know the choices, whether to approve the fundraising methods, or approve any loss of services that might be necessary. Budget shortfalls have been met from the General Fund, but Rowe explained \$15 million came from reserves, a regular withdrawal from one-time emergency funds. The idea of consolidation, Calfire taking over County Fire, likely not interested, no formal request has been made.

-Code Enforcement will be increased when the new Short Term Rental Ordinance goes into effect.

9. U.S. Bank Certificate of Deposit – HVCC 9-month CD matures in November 2019 - necessary to take a 59-month CD to continue with our original rate, Motion made and unanimously approved to let the current CD mature and put the money back into our General Fund for possible fundraiser expenses. Review in 9 months.

10. Committees:

Standing: Public Outreach (Betty Munson) agenda went out Wednesday.

Ad Hoc: Scenic Highway 247 (Betty Munson) Visual Assessment to be printed and presented to the Caltrans Landscape Architect and County Land Use Services by October 28. Draft introductory letter and Brian Hammer's maps to be included. The first time the Committee has incurred expenses. Chuck Bell said LVEDA could share expenses.

11. President's Report - Morongo Basin Municipal Advisory Council approved resolution declaring the Morongo Basin a "Hate-Free Zone" even thought an "advisory" council are merely advisors to the Supervisor. That proposal got no approval from a full house of Homestead Valley citizens, or the Council, at HVCC September meeting in Landers. Our Morongo Valley friends spoke against it. Yucca Mesa and Landers delegates approved

-Cumulative voting: SB112 authorized "rank choice" voting. Governor vetoed. Working through Dominic and Assemblyman Obernolte to acheive similar cumulative- style vote for school district.

-No response from 8-Minute Energy after he sent the HVCC position paper in opposition to industrial renewable energy projects and invited them to come to meet with us.

-Update of HVCC website should be completed before next month's meeting in Flamingo Heights.
