Rowe was asked to introduce herself, then read HVCC's pledge for officers to repeat. She also came to the February 18 meeting in Johnson Valley and answered questions.

Hot topics at both meetings: **County Fire Tax:** Cindy Henry spoke about the Fire Tax Coalition.

Looking ahead to the possibility that current litigation succeeds in bringing this to a legal vote, Henry is exploring ways and means for reaching every voter. She supplied updates on the lawsuits by The Red

Brennan Group and Ron Austin, a related annexation lawsuit by San Antonio Heights, and proposed legislation triggered by the coalition.

Policy 4.10 of the County Renewable Energy and Conservation Element of the County Plan: Supervisor Rowe had asked the Supervisors bring this to a vote as soon as possible, whether or not to approve the original language of Policy 4.10 as recommended by the Planning Commission.

Rowe urged residents in unincorporated communities to attend a special meeting on this issue alone, Thursday, February 28, and make their opinions known to the Supervisors. Attorney Steve Mills came to HVCC in February to help promote this grass roots action, to stand up in person and be counted. We won. The Board of Supervisors voted 4-1 in favor of the Policy 4.10, giving us a defense against industrial solar projects in our communities.

Supervisor Rowe confirmed she plans to meet again with the HVCC on Monday, April 15, at the Yucca Mesa Community Center. The Council invites everyone to come, ask questions and make comments.
